CLÁUSULA PRIMEIRA – DO PRAZO

1.1. O presente termo aditivo tem por objetivo a prorrogação do prazo contratual, de serviços médicos na especialidade de TERAPIA INTENSIVA com fornecimento de mão de obra capacitada, para atender os pacientes do Hospital Estadual de Doenças Tropicais – HDT, conforme originalmente pactuado e constante no Instrumento Contratual primitivo firmado pelas partes em data de 08/04/2021.






